1. Business Matters

- Atty. Jess Reotutar discussed the items in the Terms of Reference and the bidders who
 participated in the meeting raised the following concerns for clarifications:
 - Item IV. Security Detail
 - Clarification on the schedule of guards the two (2) security guards shall perform their duty in the following schedule: Monday to Friday (12 hours a day from 7:00 a.m. to 7:00 p.m.) and on Saturdays (10 hours from 7:00 a.m. to 5:00 p.m.)
 - Administrative Fee the Admin fee shall be 20% based on the existing contract
 - Item III. Attire of the Security Guards
 - The representative from Redbird Security discussed with the group the proper attire of security personnel based on RA 5487 (Private Security Agency Law).
 - Wearing of Type A uniform (white barong) the security guard will not be issued a gun, if ever the client requires the issuance of a gun, an authorization from the SOSIA (Supervisory Office on Security and Investigation Agencies) is needed.
 - Wearing of the prescribed uniform for guards issuance of a gun is allowed and can be carried by the guard while on duty
 - The BAC shall discuss the matter with the management and will advise the prospective bidders accordingly. The use of the stun gun will also be considered in lieu of the issuance of a gun.
 - The BAC clarified to the prospective bidders that whoever wins in the public bidding, the existing two (2) security personnel will be absorbed by the new service provider.
