- The issue on display port connector was also discussed. The bidders requested that the word "serial port" be deleted.
- The body agreed that a bid bulletin shall be issued to clarify all issues raised during the meeting.
- The delivery schedule specified under Section VI. (Schedule of Requirements) shall be changed from 15 to 20 days to 45 to 60 calendar days after receipt of Notice to Proceed.
