

Invitation to Bid for Server Room Renovation (G-2022-ServerRoom-Renovation-10)

- 1. The Small Business Corporation (SB Corporation), through the Corporate Operating Budget for 2022, intends to apply the sum of PESOS: Four Million Five Hundred Thousand (P4,500,000.00) being the ABC to payments under the contract for the Server Room Renovation (Ref.: G-2022-ServerRoom-Renovation-10). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The SB Corporation now invites bids for the above Procurement Project. Delivery of the Goods is required within ninety (90) calendar days upon receipt of Notice to Proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from SB Corporation and inspect the Bidding Documents at the address given below during office hours from 9:00 a.m. to 4:00 p.m..
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on November 25 December 13, 2022 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of P5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees upon payment in the Cashier of SB Corporation.
- 6. The SB Corporation will hold a Pre-Bid Conference on December 2, 2022, 10:00 a.m. at the 18F Conference Room and/or through video conferencing via zoom, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before *December 14*, 2022, 1:30 p.m. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

- 9. Bid opening shall be on *December 14, 2022, 1:30 p.m* at the given address. Bids will be opened in the presence of the BAC, TWG members, Observers and Bidders who wish to attend.
- 10. The *SB Corporation* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
