



## Invitation to Bid for Leased Line Internet Connection (G-2023-LeasedLineInternet-01)

- The Small Business Corporation (SB Corporation), through the Corporate Operating Budget for 2023, intends to apply the sum of PESOS: TWO MILLION ONE HUNDRED SIXTY THOUSAND (P2,160,000.00) being the ABC to payments under the contract for Leased-Line Internet Connection (Ref.: G-2023-LeasedLineInternet-01). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The SB Corporation now invites bids for the above Procurement Project. Delivery of the Goods is required within thirty (30) calendar days upon receipt of the Notice to Proceed. Bidders should have completed, within one (1) year from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from SB Corporation and inspect the Bidding Documents at the address given below during office hours from 9:00a.m. to 4:00 p.m..
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on Feb. 28 March 19, 2023 from the given address and website(s) below [Insert if necessary: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of P2,160.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees upon payment in the Cashier of SB Corporation.

- The SB Corporation will hold a Pre-Bid Conference on March 08, 2023 at 10:00a.m. at the 18F Conference Room and/or through video conferencing via zoom which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through manual submission at the
  office address indicated below, on or before March 20, 2023, 10:00a.m. Late bids
  shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- Bid opening shall be on March 20, 2023, 10:00a.m at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The SB Corporation reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
