TERMS OF REFERENCE

RENEWAL OF ONE (1) YEAR SUBSCRIPTION OF SOLARWINDS NETWORK PERFORMANCE MONITORING LICENSE

OBJECTIVE

The project aims to continue the real-time monitoring of SBC's IT network assets in anticipating failure of any devices enrolled in the monitoring system. This will help ITG-InfraTeam to act accordingly on downtime of network connection and services of other IT resources. Also, with its reporting features, this will provide ITG with the necessary data for the reporting of the status of SBC's IT Infrastructure to the Management.

II. SCOPE OF WORK

The project calls for the renewal of Solarwinds Network Performance Monitoring License to be used in SBC's IT resources. This subscription-based license, upon renewal, will continue to monitor the network performance of all enrolled IT assets with one year subscription period from July 2023 to July 2024.
