# RENEWAL OF NETWORK SECURITY MODULE LICENSE FOR SOPHOS XGS136 (DAVAO)

#### OBJECTIVE

to Kara Element

The project aims to continue the protection of SBC's Area Office from both internal and external threats lingering in the local area network of the said office which has an IPSec protocol connection in the head office. If not secured, the threats may propagate in the head office and the treatment of such can burden the load of protection of the unified threat management appliance installed in the head office.

### II. SCOPE OF WORK

The project calls for the renewal of network security module license for Sophos XGS136 located in SBC Davao office. This subscription-based license will be installed/loaded in the Sophos XGS136 Firewall Appliance deployed in the office with one year subscription period from April 2024 to April 2025.

## III. TECHNICAL SPECIFICATIONS
